

## TRADITIONAL IRA CONTRIBUTION REMITTANCE FORM

In order to make a regular contribution to a Traditional IRA, you must first have established a Traditional IRA by completing and returning a Traditional IRA Enrollment Form to Pension Fund, and you must be (i) a current employee of an employer that is eligible to participate in the Defined Contribution Retirement Accounts of the Pension Fund of the Christian Church (Disciples of Christ) ("DCRA") or (ii) the spouse of such eligible employee. You can make regular contributions to the Traditional IRA from your spouse's taxable compensation if you file a joint tax return with your spouse.

Do not use this Form to make a rollover contribution or transfer to a Traditional IRA, including a recharacterization. Use the Application for Rollover/Transfer to Traditional IRA instead.
